Agreement on Co-establishing an Internship Base

Party A: Hunan City University

Party B: Hunan Construction Investment Group Co., Ltd.

In the spirit of resource sharing and complementary advantages, and to promote the mutual development of both Party A and Party B, the two parties agree to co-establish an internship base for Hunan City University.

Through mutual consultation, the following agreement is reached:

1. Both Party A and Party B will jointly form a leadership group for the construction of the internship base, consisting of leaders from Party A's internship management department and leaders from Party B's unit (or department). This group will oversee the planning of the internship base and coordinate solutions to any difficulties and problems encountered during the cooperation.

2. Both Party A and Party B will incorporate the construction of the internship base as outlined in this agreement into their annual work plans and implement it accordingly.

3. Responsibilities and Obligations of Party A:

(1) Strengthen the overall planning of internship work and jointly arrange internship plans with Party B.

(2) Enhance the education of interns in terms of ideology,

organizational discipline, moral integrity, and safety. Educate students to comply with relevant laws and regulations as well as Party B's management systems during the internship period, and to maintain the confidentiality of Party B's trade secrets.

(3) Assign responsible and experienced internship instructors or liaison teachers to maintain regular contact with Party B.

(4) Strengthen collaboration with Party B in educational research or production research, and establish research topics as needed to jointly carry out research projects. Specific content will be determined through separate agreements as circumstances require.

(5) Honorary appointments may be made to Party B personnel as needed, and those appointed may be invited to give special reports, lectures, or participate in corporate promotions or recruitment activities at the university.

(6) Provide priority services to the internship base unit in areas such as talent training, consulting services, and information exchange.

(7) Utilize its own advantages to recommend graduates to Party B.

(8) Award Party B the plaque of "Hunan City University Internship Base."

4. Responsibilities and Obligations of Party B:

(1) Provide priority internship conditions and conveniences for Party A's students, accept Party A's students for professional internships

annually, propose specific internship arrangements, and assist Party A in completing internship teaching tasks.

(2) Establish an internship guidance group, formulate internship management documents, and create internship management archives. Arrange appropriate professional and technical personnel and management staff to participate in the guidance and daily management of interns, and incorporate the management of Party A's interns into Party B's employee management system.

(3) Assign leaders to participate in the supervision of Party A's internship teaching quality and provide constructive opinions and suggestions.

(4) Assign experienced professionals to participate in the cultivation of Party A's students' abilities during off-campus internships, and provide timely professional training and employment guidance to Party A's students.

(5) Invite or hire Party A's teachers to train employees, teach relevant professional knowledge, or participate in management and research and development as needed.

(6) Participate in the assessment of Party A's internship students and fill out the internship evaluation form for Hunan City University students.

(7) Summarize the construction of the internship base, assist Party

A in holding summary meetings for the internship base construction, and cooperate with Party A to apply for provincial and national outstanding internship bases as needed.

(8) Give priority to hiring graduates recommended by Party A under equal conditions.

5. Other Matters:

(1) Any other matters not covered in this agreement will be resolved through separate negotiations between the two parties.

(2) This agreement is made in two copies, and will take effect after being signed and sealed by both parties. Each party will hold one copy.

(3) This agreement is valid for five years, starting from the date of signing.
